

# Pstoedit plugins – Additional format drivers for pstoedit.

## 1 Introduction

The plugins.dll and the binary distributions available via <http://www.pstoedit.net/plugins/> contain additional backends for pstoedit. They are currently available for Windows, Linux and Solaris. The Windows version comes as a separate DLL. Just copy the plugins.dll to the same directory where you installed the pstoedit.dll (?:\??\gstoools\??\pstoedit). The Linux and Solaris version are already compiled into the binary distribution of the pstoedit executable for these platforms – nevertheless you need a license to use them without restrictions.

Currently the following additional drivers are available:

- CGM (binary (V1 and/or V4) and textual)
- EMF Enhanced Windows Metafiles (a much better version (full rewrite) than the one that comes with pstoedit)
- MIF for FrameMaker
- Scalable Vector Graphics (SVG). One candidate of the W3C for a web standard for vector drawings. See <http://www.w3.org/Graphics/SVG/> for more details.
- RTF Rich Text Format. Although the generated RTF file can be loaded into word processing programs such as MS Word, it is not suitable for doing large changes since every page is represented as one graphic object.

After installation of the plugins.dll in the pstoedit directory, pstoedit will automatically know about the additional formats. You can run “pstoedit –v –help” to see whether this is the case. Also if you use pstoedit from within gsview, the additional formats will be available.

Unless you get a key, these drivers will slightly distort the generated output. Colors will be changed and the letter e will be replaced by \$.

## 2 Known problems and limitations

- Same as for pstoedit. Notably:
  - Clipping is not fully supported for all backends - it works quite well for SVG.
  - Only a subset of all PostScript raster operators is supported and only for SVG, MIF and EMF/RTF.
  - PDF files protected by password cannot be opened even if the password is known.
